## **Scope of Work**

The Noida Sports Trust has focused on providing excellent Pro Shop services and facilities to the players/members/visitors of the Stadium. The successful applicant must be able to demonstrate the following attributes:-

1. Strong customer service ethos and clear customer value proposition.
2. An exciting and diverse items/equipments and service.
3. Demonstrated business acumen.
4. Provide branded apparels/sports gear/equipments etc.

## **Terms and Condition**

1. Bidders are advised to inspect, measure and examine the site and satisfy themselves with site conditions, before submitting their bids. No measurements will be provided by the office of Secretary, Noida Sports Trust.
2. The prospective bidders are requested to go through the enclosed, Terms and Conditions of the contract carefully.
3. The Contract will be awarded for a period of three years which can be extended further subject to satisfactory performance of the contractor for maximum of two year period with an increase of 15% in the monthly fixed fee.
4. Noida Sports Trust reserves the right to award the contract to one tenderer depending upon H-I rates quoted in the tender.
5. Noida Sports Trust reserves the right to accept or reject any or part of the items found inferior in quality of workmanship or/and the quality of materials/goods.
6. Firms with single proprietorship are eligible for participation in the tender.

- 7.** Tenderers may please quote their unconditional rates. The price quoted at the time submission of tender should remain valid for 180 days from the date of tender opening and the rates finalized on the basis of these prices shall remain in force during the currency of the contract which will normally be for a period of one year. It may specifically be noted that no changes/escalations in the accepted rates shall be allowed during currency of the contract.
- 8.** The contractor shall be responsible for payment of wages/ settlement of dues with workers engaged by the firm as per prevailing labour/ wage laws in force NOIDA SPORTS TRUST shall not be a party to any dispute between the contractor and workers.
- 9.** The prospective bidders are free to seek any clarifications/ see the kind of requirement's from General Manager, Stadium (Telephone No. 9811078735), who may be contacted with prior appointment on any working day within one week of tender date.
- 10.** If any of the bidders have any objection with regard to the terms and conditions of the tender, the same may be pointed out within 5 calendar days of the issue of the tender documents.
- 11.** The job carried out shall be to the satisfaction of Noida Sports Trust; else Noida Sports Trust reserves the right to blacklist the agency for a suitable period or from further participation in any of the Department's contracts. The decision of the competent authority of Noida Sports Trust shall be final and binding on the firm/agency.
- 12.** If it is found that the contractor has violated these conditions, the contract will be terminated forthwith without any notice.
